SEAL of Excellence School Award

The California Association for Bilingual Education is proud to announce that it is accepting nominations for the CABE 2023 Seal of Excellence Award. The Seal of Excellence Award was inaugurated in 1996 to honor exemplary biliteracy programs throughout the state. This prestigious award honors schools that have established effective programs for their dual language and English learner students.

To receive the CABE 2023 Seal of Excellence Award, each school must meet all the following criteria by providing the documentation. Public and Private schools in the State of California are eligible to apply. (Please note that schools who have received the Seal of Excellence Award within the last 4 years are not eligible.)

Nomination Criteria

- Substantial evidence of dual language proficiency (in English and target language) and academic achievement for dual language and English learner students in the biliteracy program
- Substantial evidence that English learners in the regular education and biliteracy programs are making sufficient progress academically to close the achievement gap as evidenced by state (e.g., CAASPP, etc.) and local formative and summative assessments
- A description of (a) the comprehensive and enriched instructional program that includes Integrated and Designated English Language Development (for all English learners at the school) and target language instruction (for those in the biliteracy program); and (b) how the instructional program provides continuous and coherent services for all students (English learners and non-English learners in regular education or biliteracy program classes) across all grade levels in the program
- A description of the professional development plan for certificated staff professional learning
- Use of effective research-based instructional strategies
- A description, with examples, of how the comprehensive biliteracy and regular education program curricula for English learners is aligned to the California content standards at all grade levels
- A description, with examples, of how the school's family and community engagement program supports parents to become active participants in and advocates for their children's education
- The alignment of the school's regular education and biliteracy programs to the four principles outlined in the California Department of Education's English Learner (EL) Roadmap (https://resources.gocabe.org/index.php/home/the-english-learner-roadmap/)
